Jacob Stuart reported that the Baker Hostetler *Central Florida Partnership* "Trip to Washington, D.C.," will be held Wednesday and Thursday, June 23 & 24, 2010. Modeling, Simulation and Training will be the emphasis for this trip. He reported that one of the most important jewels we have in our community's economic crown is the Modeling, Simulation and Training "Cluster," whose concentration is found in the Central Florida Research Park and which is anchored by our military partners.
